# Covid Shots for Adults & Children: What We Know Now



#### PEOPLE ARE DOING FINE WITHOUT THE SHOTS:

- According to the Centers for Disease Control and Prevention (CDC), the "infection fatality rate" (IFR) for Covid is less than 1.3 percent for people aged 65 and older; the IFR for children and adolescents is 0.0009 percent.<sup>1</sup>
- · Symptoms in children and adolescents are generally mild.2
- In April 2022, the CDC estimated that about 75 percent of America's children and adolescents had already had Covid.<sup>3</sup>

## THE SHOTS WON'T PREVENT COVID-19 AND COULD LEAD TO EVEN WORSE OUTCOMES:

- Manufacturers originally claimed their Covid shots were 95 percent effective.<sup>4</sup> CDC's director now admits Covid shots do not prevent Covid.<sup>5</sup>
- Data from 145 of the most vaccinated countries show that Covid shots are associated with a 31 percent increase in deaths.<sup>6</sup>
- Double "vaccinated" individuals aged forty and over are more likely to die "of Covid" than unvaccinated individuals. Data also show that double "vaccinated" people over eighteen are two to three times more likely to get Covid; and those over thirty are up to two times more likely to be hospitalized.<sup>7</sup>

#### ADVERSE REACTIONS ARE TO BE EXPECTED:

- In every clinical trial of Covid shots, nearly all participants reported adverse reactions, including high fever, chills, muscle pains and headaches.
- Some reported severe reactions that required hospitalization and invasive treatment.<sup>8</sup>
- An internal Pfizer document released by the Food and Drug Administration (FDA) in March 2022 revealed that the company knew its injections were linked to an extremely high number of illnesses, injuries and deaths.<sup>9</sup>
- The document disclosed that in the first three months of the Covid-19 injection rollout, Pfizer received 42,086 case reports capturing 158,893 different adverse events, including 1,223 deaths.
- The average person (case) suffered from about four different symptoms (events),<sup>10</sup> and one in thirty-five persons who reported adverse events died.<sup>11</sup>

#### **ADVERSE REACTIONS ARE NOT RARE:**

- There have been more reported adverse reactions and deaths from Covid shots than all other vaccines combined.
- As of November 4, 2022, the Vaccine Adverse Event Reporting System (VAERS) displayed more than 1.4 million adverse events following Covid "vaccination," including nearly thirty-two thousand reported deaths.<sup>12</sup>
- Most vaccine injuries and deaths go unreported. According to a Department of Health and Human Services (HHS) study, only 1-10 percent of adverse reactions and deaths are reported to VAERS.<sup>13</sup>
- Analysis of VAERS data showed twenty-two cases of life-threatening

- side effects of Covid shots experienced by infants and toddlers under age four by early September 2022.<sup>14</sup>
- As of early September 2022, VAERS data showed almost four thousand adverse events (including eight deaths) in children under age five, nearly fourteen thousand adverse events (including twenty-eight deaths) in kids between ages five and eleven, and more than thirty-nine thousand adverse events (comprising one hundred twenty-one deaths) in adolescents ages twelve to seventeen.<sup>15</sup>
- In Thailand, 29 percent of young recipients of Pfizer's Covid shots experienced heart problems in a study involving several hundred adolescents (aged thirteen to eighteen).<sup>16</sup>

## THE SHOTS ARE AFFECTING MENSTRUAL CYCLES AND CAUSING MISCARRIAGES, AND COULD MAKE WOMEN STERILE:

- An analysis published in July 2022 found that 42 percent of women with previously regular menstrual cycles reported bleeding "more heavily than usual" after receiving Covid shots.<sup>17</sup>
- Research links abnormal menses to uterine and cervical cancers, bleeding disorders, thyroid dysfunction, other pituitary disorders affecting hormonal balance, infection and perimenopause.<sup>18</sup>
- Covid shots could potentially cross-react—in ways that might impair reproduction—with syncytin (a protein that is "an essential prerequisite for a successful pregnancy") as well as with reproductive genes in sperm, ova and placenta.<sup>19</sup>
- Studies show that lipid nanoparticles in the mRNA Covid shots have a "special affinity" for the ovaries as well as the liver and spleen.<sup>20</sup>
- Research found that two doses of Pfizer's Covid shots impaired semen concentration and motile counts in men for at least three months.<sup>21</sup>
- Pfizer documents, released by court order, confirm that in women whose pregnancy outcomes were known, 87.5 percent of pregnancies ended in a miscarriage during clinical trials.<sup>22</sup>
- A widely circulated, CDC-sponsored study used to claim that the shots are safe during pregnancy misreported its pregnancy loss data—the actual miscarriage rate was 82 percent.<sup>23</sup>

## THERE IS AMPLE CAUSE FOR CONCERN ABOUT THE COVID SHOTS' INGREDIENTS, NOT ALL OF WHICH HAVE BEEN DISCLOSED:

- History shows that all vaccines and their toxic ingredients are linked to a wide range of adverse health outcomes, including seizures, neurodevelopmental disorders and infant death,<sup>24</sup> and the Covid shots are no different.
- The mRNA Covid shots include polyethylene glycol (PEG), an immunogenic chemical compound associated with severe and potentially fatal allergic reactions.<sup>25</sup>
- Some Covid shot batches have been found to contain metallic particles;<sup>26</sup> and all mRNA shots contain dangerous lipid nanoparticles, which can create a series of toxic reactions, including damage to DNA.<sup>27</sup>



## THE SAFETY OF ADMINISTERING COVID SHOTS AT THE SAME TIME AS OTHER SHOTS HAS NOT BEEN STUDIED:

- The UK has BANNED Covid vaccines for all children under age twelve.<sup>28</sup>
- In the U.S., in contrast, FDA authorized the shots for babies as young as six months.
- There are no studies showing that it is safe to administer Covid shots concurrently with other childhood vaccines (nor has the safety of administering any of the vaccines on the childhood schedule in combination with other vaccines ever been studied).
- Nevertheless, the CDC's Advisory Committee on Immunization Practices (ACIP) recommends that doctors give the Covid shots on top of the other vaccines CDC already recommends for six-monthold babies (up to nine vaccines on the same day) and fifteenmonth-old toddlers (up to eleven on the same day).<sup>29</sup>
- The U.S. ranks forty-fourth in the world for children's health, and more than 54 percent of American children have one or more chronic illnesses. What will happen to our vulnerable children who already receive up to 69 doses of 16 recommended vaccines<sup>30</sup>—if we also "vaccinate" them with potentially dangerous Covid shots?

## **COVID SHOTS ARE LIABILITY-FREE:**

- Under U.S. law, the manufacturers of the Covid shots are protected from all liability—if you are injured, you cannot sue.<sup>31</sup>
- Who will help with medical bills if you or your child is injured? Who will care for your child? Are you willing to take the risk?
