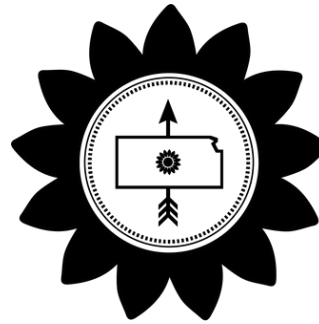

The Freedom Revival in the Heartland Logo

Logos are far more than a simple image. They evoke mood and emotion - they bring together elements of an event's inspiration - they communicate a vision - they paint a picture of the heartbeat behind an event - they **STAND** for something! Our Freedom Revival in the Heartland logo is no exception. An extraordinary amount of design, thought, heart, and prayer went into it. (Perhaps too much - ha! - but we felt a sense of responsibility to get it juuust right). With all that is behind and within it, we wanted to share its inspiration with all of you.

The Event Name

"Freedom" has always been at the core of this event. However, the word "revival" came later. The original title was "Freedom Rally in the Heartland." Yet this event felt so much **BIGGER** than a rally. The word "revival" was brought to the table, confirmed over and over again through prayer, and **STUCK!**

The State Outline

Read through the Kansas history page of this booklet and you will begin to understand why Kansas has been proclaimed and preserved as God's "heartland." We have such a rich, powerful history of strength, freedom, and standing for what is right. Many people, tribal nations, churches and other groups have been praying for Kansas for generations, and that continues strongly even today.

The Sunflower / Sun Outline

It is no secret that the sunflower is the Kansas state flower. However, you may not have realized how special sunflowers truly are. Have you ever tried to pull a sunflower up from the ground? It is nearly impossible! They are incredibly **STRONG**, deeply **ROOTED**, stand **TALL**, are full of **LIFE-GIVING** (and delicious) seeds, reach **HIGH** into the sky, and also just so happen to be yellow - the designated color of the health freedom movement. And yet, as important as sunflowers are to us here in Kansas, the logo inspiration extends even further. While preparing for this event, many of us kept feeling that this initial event in the center of our nation is meant to spark something **WAY** bigger. Therefore, the Kansas sunflower was transformed into even more of a sun - as if to portray the light of freedom, truth, healing, and love reflecting and radiating out from God's heartland to the rest of the world. We hope this event will serve to light a candle for other cities, states, and nations to feel inspired and do the same.

The Arrow

The arrow is multi-faceted and one of the most mysterious parts of our logo. Even the events team is still learning more about it as God continues to reveal to us what He had in mind for its inclusion! From the beginning, we had a strong sense that Native American symbology was destined to be a part of our logo. (Again, read our Kansas history page to learn more about that). Several images were considered, including Wichita's iconic Keeper of the Plains. Then, the arrow emerged. The arrow unmistakably points up - reaching to the heavens, revealing true north, and providing hope as if to say "onward and upward we go, **TOGETHER!**"

The Seal

The logo, and all the meaning wrapped up in it, is then stamped with a final seal. Seals give an image authority and stand as an official emblem, a mark of identification - the perfect finishing touch to the multi-faceted and inspirational icon for this event.

Kansas: A Rich Tradition of Freedom“

I am willing to die for the cause of freedom in Kansas”--David Buffum, Lawrence, KS, 1856

As a small girl born in our state capital of Topeka, Kansas, I was immersed in the fascinating and diverse history of Kansas from a very young age. The Heartland's history revolves around the struggle for freedom. Sometimes the fight to be free was lost. Early Kansas history stems from the stories of the Native Americans and includes the Trail of Death of the Potawatomi Tribe, which ended in Miami County, Kansas.

Other times, the fight for freedom was won. In the 1850s, the eyes of the nation were upon Kansas. Kansas had just become a territory, and the whole country watched its approaching statehood to learn which way the balance of power would shift between North and South. The Kansas-Nebraska Act of 1854 allowed the people living in the Kansas Territory to decide by popular sovereignty whether their state would allow slavery. Kansas's territorial seal includes the Latin motto, “Populi Vocenata,” which means “born by the voice of the people” or “born of the popular will.” Pro- and anti-slavery activists flooded into the territory to sway the vote, and when violent clashes ensued, Kansas became known as “Bleeding Kansas.” Everyone expected Kansas to fall in line with Missouri and also be pro-slavery, but the people of the Heartland chose freedom for all. In 1861, Kansas was admitted to the Union as a free state.

In 1877, formerly enslaved African Americans left Kentucky at the end of the post-Civil War period to experience freedom in the “promised land” of Kansas. For many African Americans, Kansas represented freedom. Today, the National Historic site at Nicodemus, Kansas commemorates the important contributions of African Americans in the westward expansion and settlement of the Great Plains.

Many men and women from the heartland forged history in this great nation when they left Kansas to make a difference on the world stage. People such as Dwight D. Eisenhower, who became the 34th President of the United States, and Amelia Earhart, who made her mark in early aviation history as one of the first women pilots.

But countless more men, women, and children who called the Great Plains home also gave of themselves to settle this land and keep it free. They forged the Santa Fe and Oregon Trail to connect the United States from the east to the west. They survived the Dust Bowl and the Great Depression and went on to raise their families and plow new fields. They served in the military to preserve our freedom in the great wars and returned home to build new cities, towns, highways, and roads. They built resilient communities who believe in the American values of freedom, liberty, and justice for all.

Today, we gather once again to forge new trails toward freedom. Today, we seek a revival of freedom in the Heartland. A revival that will ring throughout our great nation and to the world. Let Freedom Ring!

Who We Are

Kansans for Health Freedom was started by our very own CDC - Cindy, Debbie, and Connie - in the spring of 2019. These three passionate, praying grandmothers saw what was happening to our children - the exponential rise in childhood chronic diseases, autism, and developmental disabilities - and decided they would not stand for it one moment longer. They prayed the rest of us in, and we answered their call. Twenty strangers from all over Kansas connected in our first Zoom call, and it was clear there was momentum for this cause. Our group grew like wildfire over the next few months, as we mobilized pushback against two new vaccines (hepatitis A and meningitis) being arbitrarily added to the Kansas school schedule. We are a diverse group of Kansans from all different political, lifestyle, and belief spectrums that have come together to defend our freedom to make our own health choices for ourselves and our children.

Our Mission

Kansans for Health Freedom is a 501c4 nonprofit organization created for the purpose of reclaiming and upholding individual health freedoms. We fully believe the stories of mothers and fathers who speak of vaccine injury to their children. We also believe adults who have their own personal stories of vaccine injury. We believe health is not one-size-fits-all and that health decisions belong solely in the hands of individuals and families and not the government. We take a stand against coercion, discrimination of any kind, censorship, and all mandates. We believe YOU should have the right to make healthcare decisions for yourself and your family, and with the proper informed consent. (Which implies full transparency and an evaluation of all risks and benefits). KS·HF has come together to fight to: Stop vaccine-related injury and death. Mobilize the grass roots of Kansans to stand against all health-related mandates. Persuade our lawmakers to legislate true informed consent for all medical procedures in our state. Re-establish financial liability for vaccine manufacturers responsible for vaccine injuries in our state. Uphold and defend parental rights.

What We've Done

It's amazing what you can get done when you're fueled by love, community, prayer, and justice! In just one year, KS·HF has accomplished a lot:

- Drafted and proposed a bill in the Kansas legislature to limit the power of the unelected KDHE Director to add new vaccines to the required childhood immunization schedule. While our bill did not succeed, we made our presence and our political power well known! With hundreds of written testimonies and hundreds in attendance, the hearing on our bill was the largest in our state Capitol's history!
- Testified in Topeka with dozens of members at two different public hearings on vaccine issues, which further strengthened our relationships with many legislators.
- Sent nearly 80 fact-based, well-documented educational emails to Kansas legislators, county commissioners, and health departments on a range of health freedom topics from vaccines to masks to COVID-19 testing, including a 9-part in-depth series on the risks associated with developing a coronavirus vaccine. - Collected and archived a number of vaccine injury stories from Kansas parents and citizens, many of which were sent to legislators.
- Forged relationships and built trust and mutual respect with our legislators. We believe we have opened many eyes among our lawmakers about the many problems with the CDC vaccine program and the importance of health freedom.
- Mobilized nearly a hundred members at our "Capitol Connect Day" in Topeka, when we met with legislators in their offices and made our concerns about vaccine safety and the corruption in the vaccine program known.
- Built a strong online presence via our website, 2,000+ member Facebook group, 1,100+ followers on our public Facebook page, and an active Instagram page.
- Designed and sold t-shirts to bring awareness to our cause and our organization.
- Created and printed 9 detailed informational fliers about KS·HF and vaccines, as well as pamphlets, business cards, legislator surveys, and more.
- Launched a billboard campaign to educate about the potential COVID-19 vaccine. KS·HF now hosts 11 billboards across Kansas.

This documentary focuses narrowly on one vaccine given to military members and first responders, and is entirely informed by that population of articulate and well educated adults. It provides a valuable perspective on what a mandatory vaccination program looks like from the inside out. The goal of this 17 year long project was to open the discussion to whether a soldier, airman or marine should face court martial for refusing a vaccine. Since then, the promotion of mandatory vaccines for school age children, the promotion of flu vaccines with no ability to properly screen adverse reactions and new legislation to force vaccination with experimental drugs, begs the question of whether or not it is possible for a doctor to give informed consent.

In the early 90s, a mysterious muscular disease with symptoms that included severe muscle and joint pain began to surface among multiple patients in France. A team of doctors in Paris discovered that these patients had developed a new disease called Macrophagic Myofascitis, or MMF, which occurs when the aluminum hydroxide adjuvant from a vaccine remains embedded in the muscle tissue. What the pharmaceutical companies don't make public is that the aluminum adjuvant was never rigorously tested before going on the market and there are alternative, much less toxic, adjuvants available.

The pharmaceutical industry used faulty research, paid doctors and manipulated the media to push an unsafe vaccine onto the market. They used political pressure to force this vaccine onto the public, despite any demonstrable public threat. The result has been the devastation of many young girls' lives. Through interviews with leading experts, victims, and our own analysis of the vaccines themselves, the Alliance for Natural Health uncovered a conspiracy of greed that is being perpetrated on families around the world.

The HPV vaccine is a treatment in widespread use but its efficacy in preventing cancer is medically unproven, while unintended, adverse reactions are blighting and even ending the lives of girls and young women across the world. 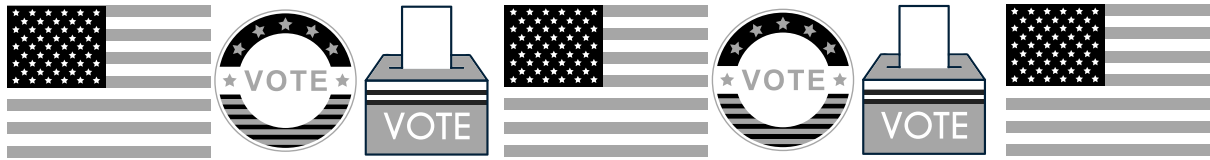

How to Register to Vote and Election Information Tips & Tricks

1 - Register to vote – Deadline October 13, 2020

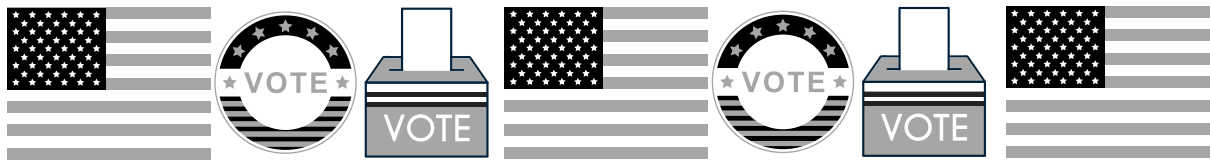
- **Who Can Vote?**
 - be a citizen of the United States
 - be a resident of Kansas
 - be 18 yrs. old by the next election
 - have completed the terms of your sentence if convicted of a felony; a person serving a sentence for a felony conviction is ineligible to vote
 - not claim the right to vote in any other location or under any other name
 - not be excluded from voting by a court of competent jurisdiction
- **Steps you must complete in the online voter registration process:**
 - verify your voting eligibility
 - verify that you have a valid driver's license or non-driver's identification card
 - enter your personal information
 - review and submit your information
- **Go to the link below to register to vote online or get information on how to use the paper form to register.**

 - **NOTE:** You must re-register each time you change your name, address, or party affiliation for voting

2 - Find out your polling place location & look at a sample ballot

- **This is a neat website where you can track your mail in ballot if you voted that way, find out your polling place location, and look up a sample ballot. A sample ballot is not currently available for the General Election, but I assume there will be one as we get closer to the election.**

 - email the candidates and ask questions on topics that are most important to you.

Robert F. Kennedy, Jr. is an American environmental attorney, author, and proud advocate and leader in the vaccine risk awareness movement. Kennedy serves as Founder, Chairman of the Board, and Chief Legal Counsel for Children's Health Defense, President of Waterkeeper Alliance, and counsel to Morgan & Morgan, a nationwide personal injury practice. For over three decades, Robert F. Kennedy, Jr. has been one of the world's leading environmental advocates. He is the founder and president of Waterkeeper Alliance, the umbrella group for 300 local waterkeeper organizations in 34 countries that track down and sue polluters. Under his leadership, Waterkeeper has grown to become the world's largest clean water advocacy organization. Around 2005, parents of vaccine-injured children began encountering Mr. Kennedy's speeches and writings about the toxic mercury-based preservative thimerosal. They embraced new hope that this environmental champion would expose the truth about vaccine injury and win justice for injured children. Soon after, Kennedy launched his non-profit, the Children's Health Defense (CHD), whose mission is to end the childhood health epidemics by working to expose their causes, eliminate harmful exposures, hold those responsible accountable, seek justice for those injured, and establish safeguards so it never happens to our children again. Kennedy is known for his fierce and relentless brand of environmental activism and his advocacy for transparent government and rigorous science. He is now applying his tenacious energies and sophisticated strategies to exposing the fraud and corruption within the CDC and the pharmaceutical industry. As part of holding those responsible accountable, CHD pursues multiple legal initiatives in an effort to defend the health of our children and obtain justice for those already injured. His reputation as a resolute defender of the environment and children's health stems from a litany of successful legal actions. He received recognition for his role in the landmark victory against Monsanto last year, as well as in the DuPont Case that inspired the movie "Dark Waters" (2019).

Dr. Andy Wakefield is an academic gastroenterologist and filmmaker. He received his medical degree from St. Mary's Hospital Medical School, University of London. He was awarded a Fellowship of the Royal College of Pathologists in 2001, and he has published over 150 original scientific articles, book chapters, books, and invited scientific commentaries. In the pursuit of possible links between childhood vaccines, intestinal inflammation, and neurological injury in children, Dr. Wakefield lost his job, his career, his fellowships, and his medical license. He is the director of the documentary film VAXXED and co-founder of the Autism Media Channel.

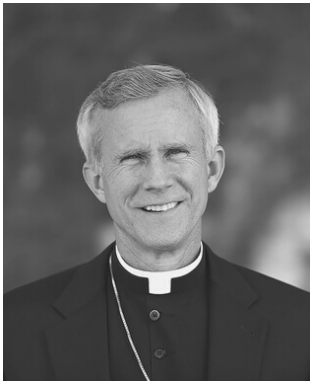

Vaccine Injury Stories

The following stories were collected and condensed from real Kansas citizens. We have received many, many more and are working on posting them on our website, in full form, as written by the individuals and families affected. We deeply honor these parents and individuals by giving voice to their stories--and by believing them.

Maggie's Story

Maggie was born perfectly healthy--a normal pregnancy, uneventful birth, and high APGAR score. 45 minutes after receiving the aluminum-laden Vitamin K shot--which is labeled with a black box warning and lists the possibility of death as a side effect on its insert--Maggie turned gray, went into respiratory distress, and was life-flighted to the NICU. The doctors had no explanation for why. Maggie is now autistic. Her parents report that she would regress after each one of her shots. MRIs now show she has scar tissue on her brain, likely from the encephalitis--also listed as a side effect on most vaccines--caused by her vaccinations.

Louis's Story

Louis was a healthy 9-month-old who easily recovered from mild illnesses until he received his vaccines. After a few months of getting vaccinated, he was so sick he had to be hospitalized. He had infections in his ears, eyes, and lungs, and was lethargic and unresponsive for days. His doctor concluded that he had encephalitis, or brain damage, and that it was likely a reaction to his vaccines. He had lost his balance, could not digest the foods he used to, was underweight, and had behavioral problems such as violent acting out and thrashing. Louis's three other siblings, who were previously healthy and 100% unvaccinated, began receiving one shot every month in order to "catch up" with the schedule so their family could move to Africa for missionary work. The children all slowly developed chronic allergies, ear infections, and had difficulty recovering from what formerly would be minor coughs and colds.

Jacob's Story

Jacob was born with a number of chronic health problems and often had adverse reactions to his vaccinations. When his two teenage brothers, Connor and Patrick, received the meningococcal vaccine, Jacob developed unexplained seizures and a high fever within three days. At the ER, doctors told Jacob's mother that her son showed all the symptoms of meningitis. Dee was shocked to find that this vaccine can shed meningitis. Connor also felt unwell with a headache and slept for three days after receiving it.

Chris's Story

Without parental consent, an eight-month-old boy named Chris was injected with eight vaccines in one appointment. Two hours later his inconsolable screams and high fever began and lasted for days. Once he stopped screaming, this previously healthy baby lost a drastic amount of function. He could barely swallow, made no sounds, made no eye contact, and lost the skills he had previously acquired. He later developed a seizure disorder, autism, reactive hypoglycemia, celiac disease, PANDAS, Lyme, apraxia, strokes, verbal clicking, facial tics, head banging, violent aggression, chronic nosebleeds, B12 deficiencies, multiple food allergies and allergies to all seizure medications. His first hour-long seizure at age 5 stopped his breathing and sent him to a trauma hospital. Seizures continued over the next 10 years. Unable to qualify for financial assistance from the National Vaccine Injury Compensation Program, his grandparents desperately struggle today to provide the care that Chris requires. They wonder who will care for him when they are gone.

Juanelle's Story

Janelle had no health problems until she received one MMR and one DTap vaccine in order to travel overseas for a mission trip. Within twenty-four hours, her health took a drastic downward turn. For the next decade, she suffered symptoms so debilitating she had to drop out of college and give up her dreams of being a teacher or lawyer. She suffered extreme fatigue, brain fog, IBS, depression, anemia, and acid reflux so intense it caused scar tissue in her esophagus and she now has trouble swallowing her food.

Alaina's Story

Sonja has six children. Half are fully vaccinated according to the CDC recommended schedule, and the other half are vaccinated either on a delayed schedule or not at all. Her first five children all have several chronic illnesses, including epilepsy, sensory processing disorder, allergies, asthma, eczema, digestive problems, and learning disabilities. Her sixth child has received no vaccines and has no health issues. She has never had an ear infection, has no skin or digestive issues, no learning disabilities, and rapidly recovers from colds and flus compared to her siblings. Sonja's daughter, Alaina, developed a seizure condition immediately after her kindergarten shots, a condition that left her brain damaged and unable to speak, walk, or talk. After having thousands of seizures, Alaina underwent a risky surgery that stopped the seizures, but left her legally blind.

Sonja Woods - Lindsborg, Kansas

"You may choose to look the other way, but you can never say again that you did not know." A year and a half ago I was a completely different mom. Happy, and almost blissfully naïve. I did all the things I thought good moms do – which included routine "wellness" checks. Someone close to me tried to warn me "have you looked into vaccines?" And I just didn't really hear it. I didn't do the work. I trusted our pediatrician over my own intuition when it felt wrong at every appointment. I was 'just a mom' I thought – surely the doctor knew better. But then our son, who had been the happiest, most peaceful and typically developing baby became a different child and one we didn't recognize. He would scream, cry and be in an almost constant state of fight or flight. And every doctor said it was normal.. he's only fifteen months. Let's wait and see. But I knew better and finally did better. It seemed too late, but what mother ever gives up on their child? He's lived the past year and a half with PANS and a lot of symptoms of autism. We've spent our days fighting for him and working to recover and heal his body. And though sometimes the progress seems slow, he is healing. But the shame and guilt never go away. "Once you know better, you do better." So now we won't shy away from the hard conversations. We'll share our story and how imperative it is read the inserts. To do the research. Your child's life depends on it!

I wish I had known...there was no one-sized fits all solution. I wish I had known...some kids are predisposed to reactions. I wish I had known...the warning signs. I wish I had known...there was no liability for the manufacturers...and that WE pay the injury compensation. I wish I had known...we had the RIGHT to choose. I was brought up to trust the doctors. They knew more than I. They had done all the research. They had my children's best interest at heart. They would be open to my concerns and trust my judgement. My child was diagnosed with ADHD, or so I thought. She had no impulse control. She couldn't think through the dangerous consequences of actions. I remember taking her to the doctor who told me, "it's just part of being a child; she will grow out of it." I was grateful she didn't try to medicate my child, but my gut told me there was more to the story. So I continued to vaccinate. I caught her up on all her Kindergarten immunizations, and things got progressively worse. We saw extreme aggression, angry outbursts, uncontrollable crying over the simplest things, cruel words spoken...words that did not belong to my sweet, bubbly child. It often took all four adult hands, essential oils, and a heavy blanket to calm her down. Our house was completely turned upside down. We began to see regression in school. She was confusing math, switching letters in words, and struggling to read. We began to see TICS, verbal and physical, and worried about Tourette's. Initially a physician told us it was just allergies, have her use a nasal spray. Again, something didn't sit right. I knew in my soul, there was more to this. Praise God, He pointed us to the exact people we needed to determine what my child suffered from was an auto-immune disorder called PANS/PANDAS. This is an auto-immune disorder caused by a virus or toxin crossing the blood brain barrier and settling on the brain. We were "lucky" to catch it when we did, but it is an ugly disease. And TOO many children are being found to have this diagnosis resulting in any of the above symptoms mixed with anxiety, depression, ODD, OCD, and the list goes on. Their brains have been compromised by the chemicals that have been shoved into their bodies. I now have two affected by this horrible disorder that the CDC does NOT recognize as severe enough to warrant a medical exemption. We are still working on getting this into remission 4 years later. Some days it feels like one step forward, two steps back. I listen to my child CRY...asking, "why me? Will I ever be better?" I can't have guilt...I can't have regrets, but I will NEVER stop sharing our story. Our kids and their health are worth fighting for. Never underestimate the amount of knowledge of research of a mama bear protecting and advocating for her child. And NEVER underestimate the power of that mama's God-given instincts. Vaccines are NOT a one-sized fits all solution.

The Austins' Story

I have four vaccinated autistic children and two never-vaccinated completely normal children. They do not have any of the genetic factors associated with autism, but they do test very high in heavy metals, which are found in vaccines.

My grandson, whom I'll call T, was diagnosed at age 20 with high-functioning ASD (autism spectrum disorder). He suddenly lost his ability to roll over after receiving one of his infant vaccines. His speech and emotional development was delayed. Middle school is where he began to fall behind, and he still struggles today. We have spent over \$221,000 getting help for T, and we're not done yet. We believe he was damaged by the toxins in vaccines.

My nephew had adverse reactions to his 4-month shots. My sister told me about the risks of vaccines, but I didn't listen. After my son's 18-month shots (Hep A), he started losing eye contact and regressed with speech. After he turned two and received more vaccines, we started losing our boy to autism. At two and a half, he started speech therapy and was put on the waitlist for an autism evaluation. He wasn't seen until seven months later and was then diagnosed with autism, global developmental delay, absence seizures and hypotonia.

During my pregnancy I was given the chickenpox vaccine even though it clearly says on the insert DO NOT GET IF PREGNANT OR BREAST FEEDING, CAN CAUSE INJURY OR DEATH TO INFANT. I continued to get my children vaccinated. My boys would bang their heads on the floors and walls. Blank stares. Their pediatrician said it was normal. I now know that head banging is a side effect of vaccination. I was not vaccinated growing up and have always been extremely healthy.

A Family of Vaccine Injury Stories

My mother and grandmother both travelled the world extensively and got all the shots recommended for each country in the '50s and '60s. They both also have been diagnosed with seizure disorders. Seizures are listed on vaccine inserts as reported adverse reactions. When I was 18 months old, I caught the measles after being vaccinated for it. I was in the hospital for 3 days, ran 104°F fever, and ended up losing 50% of my hearing from it. My one-year-old son had a vaccine reaction; he had green diarrhea, inconsolable crying, and clingy neediness. My son ended up with dyslexia, asthma/breathing issues, and a learning disability. My one-year-old nephew had a life-threatening seizure shortly after receiving the DTap. Our family has experienced multiple other vaccine injuries.

Growing up, I always had reactions to vaccines: fever, swelling, rashes. My doctor told me the fact that I got ill with vaccinations and now have a weakened immune system tells him I'm vaccine injured.

It's not easy being vulnerable and sharing parts of your story that cause heartache. But one thing about our journey is that it helped me find my voice. And I made a promise to my children that I would never stay silent... I will never forget that moment I realized my son was vaccine injured. As an indoctrinated medical professional, I was doing what I was taught to help promote a healthy child. The sad part is, is that it actually took both of my boys being harmed to connect the dots. My youngest began to develop the very symptoms my oldest had. And I remember thinking, I will take better care of myself during my pregnancy this time, eat the right foods, take the correct supplements and even exercise my body. I mean, growing a tiny human isn't easy. My youngest contracted RSV three times and an upper respiratory illness in his first year of life (just like my oldest did). Both boys were in and out of the hospital with chronic illnesses, ear infections, eczema, asthma, and hyperactivity and focus control issues. I began to question why?? Why were my boys constantly sick and in and out of the hospital all of the time? I asked our pediatrician what he thought and all he could say was: "Get the flu shot." Really, I thought? At that moment I began researching natural alternatives, seeking answers, and ways to help my babies. One day I was on social media and a mutual friend made a post about vaccine injury with a link to a group of over two hundred thousand other stories that mimicked mine. So I joined as fast as I could and fast forward to 2018, I decided I was no longer pro-vaccine and I was also completely burnt out. The hours of research, the criticism from family and friends, the constant anxiety you feel walking into a public situation... It all started to take a toll on me. You realize you're going against the "status quo" and basically what ninety percent of the population accepts. It's not easy raising a child with special needs and on top of that have friends and family turn their backs on you because you decided you no longer believe in vaccines. Regardless of how tough this journey has been, it gave us a voice, it gave us a purpose, and ultimately changed our lives for the better! Not only do our boys now have open conversations with others about vaccine injury and medical freedom, but they are also standing up for their liberties too. We are teaching them to be free thinkers, and to me that makes everything we have been through purposeful.

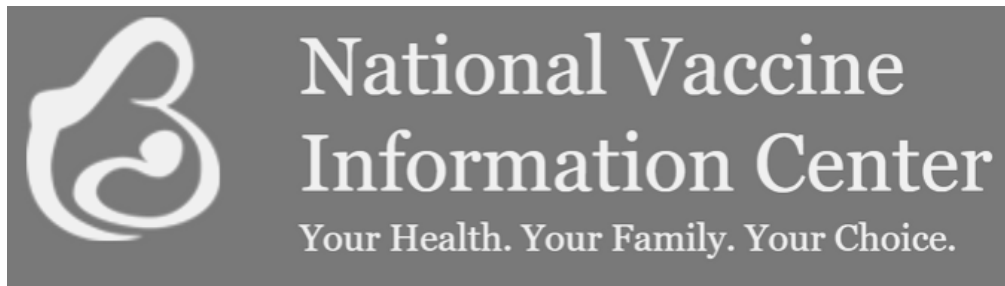

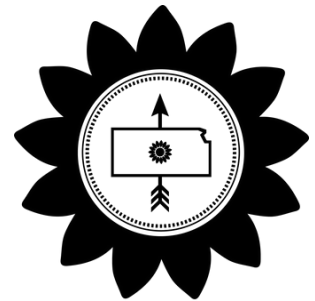
